ADMINISTRATIVE REQUIREMENTS

- 1 ONE (1) COLOR PHOTOGRAPHY, 4 X 4 CM (SHOULDERS AND FACE EXPOSED, NOT HEADCOVERING, WHITE BACKGROUND) RECENTLY TAKEN (NO MORE THAN SIX (6) MONTHS)
- 2 FORM F-76 (TIT) "APPLICATION FOR TECHNICAL DOCUMENTATIONS FOR SEAFARERS" DULY FILLED OUT AND SIGNED WITH BLACK INK.
- 3 ORIGINAL PERSONAL IDENTITY DOCUMENT: FOR **NON-NATIONALS** (VALID PASSPORT) / FOR **PANAMANIAN**S (VALID PERSONAL IDENTITY CARD OR VALID PASSPORT).
- 4 VALID MEDICAL CERTIFICATE ACCORDING THE SECTION I/9 OF THE STCW'78, AS AMENDED, AND/OR THE MLC 2006, AS AMENDED (ORIGINAL DOCUMENT). *(For this position, an OGUK medical Certificate is accepted)*
- 5 EXPERIENCE OR SUPPORTING DOCUMENT FOR THE POSITION:
 - 5.1 EMPLOYMENT LETTER, OR
 - 5.2 EXPERIENCE LETTER IN THE REQUESTED POSITION, OR
 - 5.3 TITLE.
- 6 SECURITY PROFICIENCY CERTIFICATE (**MUST BE ENDORSED BY PANAMA MARITIME AUTHORITY**) :
 - 6.1 SECURITY AWARENESS TRAINING FOR ALL SEAFARERS (A-VI/6-1), OR
 - 6.2 SECURITY TRAINING FOR SEAFARERS WITH DESIGNATED SECURITY DUTIES (A-VI/6-2), OR
 - 6.3 SHIP SECURITY OFFICER (A-VI/5)

TECHNICAL REQUIREMENTS

- 7 STCW'78 TRAINING RECOGNIZED OR ISSUED EITHER BY PMA OR ANY PARTY OF THE 1978 STCW CONVENTION, AS AMENDED AND NOT RESTRICTED BY PANAMA AND/OR OFFSHORE TRAINING RECOGNIZED BY OFFSHORE INDUSTRY
 - 8.1 PERSONAL SURVIVAL TECHNIQUES (A-VI/1-1 STCW'78 OR TABLE 5.5.1 IMO RES. A.1079 (28)).
 - 8.2 FIRE PREVENTION AND FIRE FIGHTING (A-VI/1-2 STCW'78 OR TABLE 5.5.2 IMO RES. A.1079 (28)).
 - 8.3 ELEMENTARY FIRST AID (A-VI/1-3 STCW'78 OR TABLE 5.5.3 IMO RES. A.1079 (28)).
 - 8.4 PERSONAL SAFETY AND SOCIAL RESPONSIBILITIES (A-VI/1-4 STCW'78 OR TABLE 5.5.4/5.5.5 IMO RES. A.1079 (28)).
 - 8.5 PROFICIENCY IN SURVIVAL CRAFT AND RESCUE BOATS OTHER THAN FAST RESCUE BOATS (A-VI/2-1).
 - 8.6 MAINTENANCE SUPERVISOR

NOTE: IF A VALID CERTIFICATE OF COMPETENCY AS CHIEF ENGINEER III/2 OR III/3, SECOND ENGINEER III/2 OR III/3 OR OFFICER IN CHARGE OF AN ENGINEERING WATCH III/1 IS SUBMITTED, REQUIRE NO ADDITIONAL TRAINING, ACCORDING THE APPENDIX 2, SECTION 3 OF IMO RES. A.1079 (28).

REVALIDATION

- *** MEET THE REQUIREMENTS 1, 2, 3, 4, 5, 6 AND 7.
- *** SEAMAN'S BOOK WITH THE SAME OFFSHORE POSITION ISSUED BY PMA.

(WORK EXPERIENCE SHALL BE ON OFFSHORE UNITS AND STATED IN THE SEAMAN'S BOOK DULY STAMPED OR IN COMPANY LETTER/S DULY LETTERHEAD DETAILING THE UNIT'S PARTICULARS (IMO NUMBER, CALL SIGN, TYPE OF UNIT, GROSS TONNAGE, PROPULSION POWER).
